## PROJECT STATUS

- **ANTICOUNTERFEIT** The Task Force for the "4-Step Approach" methodology established the ST strategy for the dissemination of ECPA approach on stopping illegal pesticides at the border
- ALIMEDE All individual participants at the market exercise signed the new contracts with ALIMEDE for 2015-2016
- SCAPA Field-based coordinator visited a number of collection centers and started to develop a database with their legal situation and needs; Office-based coordinator collects and select offers for the implementation of the communication campaign
- **SUI** A partnership with USAMV Cluj is intended for the continuation of SUI BMP dissemination; articles about the safe use of pesticides have been published on <a href="http://gazetadeagricultura.info/folosirea-pesticidelor-produse-protectia-plantelor.html">http://gazetadeagricultura.info/folosirea-pesticidelor-produse-protectia-plantelor.html</a>
- MARKET SURVEYS for SUI and SCAPA collection centers in December 2014 AIPROM contracted the execution of two market surveys for SUI and SCAPA; the SUI survey was done in comparison with the benchmark in 2011; the results of the study show improvement in safe use management practices among farmers see attachment (Presentation\_SUI\_2015\_RO.pptx; SCAPA\_presentation\_2015.pptx)

- 2 Feb SCAPA Task Force met with RIGK management in order to discuss operational issues for 2015
- 3 Feb SCAPA Task Force met with RIGK management & inspectors to discuss collaboration with AIPROM Project Coordinator and promotion of the Program
- 10 Feb WG1 meeting took place at AIPROM office: the members of the Group discussed about the extension of the shelf-life of a product, the preparation for the transition to CLP on June 1st 2015 and the revision of Ordinance no.4/1995, the organization of a new Registration Workshop for authorities in June this year. The group is supposed to elect a new leader since the current leader leaves Romania March 1st.
- 17 Feb The first 2015 Board Meeting of the Association took place at AIPROM office. The Program is financed by ECPA and AIPROM supervises the correct implementation of the activity plan in Romania
